MEMBER DESCRIPTIONS

Lifetime Members

Must have: 1) attained the age of sixty (60), and (2) held membership in NSLHA for the 10 consecutive years immediately prior to attaining age sixty.

Full Members

Must hold: 1) a graduate degree with major emphasis in speech-language pathology, audiology, or speech and hearing science; or 2) a graduate degree and present evidence of active research, interest, and performance in the field of human communication (LC 14-2000). Members must agree to abide by the Code of Ethics of the American Speech-Language and Hearing Association (ASHA).

Associate Members

Must: 1) hold a Bachelor's degree with major emphasis in speech-language pathology, audiology, or speech and hearing science; and (2) must have not attained full member status.

First-Year Professional Members

Must: 1) have earned a degree in a speech-language pathology or audiology within the past 12 months and 2) have been a NSLHA student member. At the completion of the 12 months, a First-Year Professional is transferred to a Full Member and must pay Full Member dues in order to maintain that membership status.

Student Members

Must be enrolled in a degree program with major emphasis in speech-language pathology, audiology, or speech and hearing science at the graduate or undergraduate level.

COMMITTEES

Schools Committee: Addresses current practices and issues relative to speech, language, and hearing services in the school, and monitors, reviews, and recommends association action on state, federal and ASHA legislation which affects the speech/language pathologists and audiologists working in school environments. Committee Chair: Theresa Mourey

Legislative Affairs Committee: Works with the NSLHA lobbyist to develop strategies to monitor and respond to legislation and licensure issues on behalf of audiologists and speech-language pathologists. Provides resources and information to help NSLHA members build relationships with their lawmakers. Helps plan the program for the annual NSLHA Legislative Day at the State Capitol. Supports issues and concerns related to speech, language, and hearing professionals in schools, clinics, hospitals, research facilities, industry and universities throughout the state of Nebraska. Attends legislative committee hearings and testifies on behalf of NSLHA as needed. Committee Co-Chairs: Josh Sevier and Jessica Thoene.

Membership Committee: Oversees marketing activities as they relate to membership recruitment, engagement and promotion of the audiology and speech-language pathology professions. Chair: Garrett Nathan

Public Relations Committee: Suggests content for the NSLHA website and suggests information to post on the Facebook page, Facebook group and Twitter feed. Promotes Better Hearing and Speech Month in Nebraska. Selects NSLHA's Better Hearing and Speech Month representatives. Committee Chair: Mitzi Ritzman

Continuing Education Committee: Solicits feedback from members regarding professional development and continuing education needs. Contacts prospective speakers. Plans education for NSLHA professional development and continuing events, including: Fall Convention, webinars and workshops. Chair: Hannah Ditmars

Insurance and Reimbursement Committee: Works with the Nebraska Department of Health and Human Services (DHHS) and Medicaid managed care organization representatives to resolve issues, with a focus on providing the best quality care and services possible to clients. Identifies possible solutions and offers recommendations to DHHS. The committee also regularly discusses changes in regulations, processes and reimbursement that affect audiology and speech-language pathology services and offers constructive comments to DHHS.
