**Set-Up Time:** October 14, 2022 – 7:00 - 10:00 AM. **Exhibit Time:** Friday, October 14, 2022 – 10:00-10:30 AM, 12:00-1:30 PM and 3:00-4:00 PM. **Tear Down Time:** Friday, October 14, 2022 – 4:00-5:00 PM.

All exhibitors are recognized with signs at the event, in the convention program, on the association website and through announcements at the convention.

**All exhibitors are responsible for reading and adhering to the following policies:**

- Payment in full by check or credit card must accompany all registration forms.
- Exhibit space is reserved upon receipt of the completed registration form and payment.
- Exhibitors are expected to keep their displays open and staffed during exhibit hours.
- Exhibitors may conduct drawings for door prizes at their display table.
- WiFi and electricity are available at no additional cost, however, exhibitors are responsible for providing their own extension cords and power strips.
- Liability for all equipment and materials remains with the individual exhibitor.
- Contracts for exhibit spaces must be received by Friday, October 7, 2022 to be listed in the program.
- No refunds for exhibit fees after September 30, 2022.
